

## CARRIER LOAD & AGREEMENT FORM FOR EXEMPT COMMODITIES

1. **DRIVER RESPONSIBILITIES:** Driver (name stated below) is required to call **(888) 598-7022 EXT. 1:**
  - a) For **Dispatch** Information and Pick-Up number.
  - b) With **Loaded** Information.
  - c) With **Daily** check calls between the hours of 8am and 10 am EST.
  - d) With **Delivery** information for **all stops**.
  - e) Notify **immediately** of any breakdown, delay, late arrival, shortage or any other problem.  
**Failure to complete any of the above terms will result in a DAILY \$100.00 Carrier Pay DEDUCTION.**
2. **CARRIER RESPONSIBILITIES:**
  - a) The Carrier will be held responsible to pay for all costs related to the necessary delivery of the shipment that the carrier has requested to transport. (Including, but not limited to: Costs for truck repair, breakdowns, tolls, fuel, etc.)
  - b) Both the Carrier and the Driver are **required** to follow **any and ALL instructions** given by Barlow representatives. Once loaded, if the Carrier chooses to not comply with any instruction given by any Barlow representative, the Carrier will be held responsible to pay for any and all costs related to the necessary delivery of that shipment as well.
3. **CONFIDENTIALTY:**
  - a) Carrier will keep all information pertaining to Barlow, its business operations, and its customers strictly confidential unless disclosure is required by law or judicial process. Failure to comply will result in a 15% charge of all profits.
  - b) Carrier will not back-solicit on any of Barlow's customers or use this information to contact any potential customer.
4. **CARRIER CANCELLATION:**
  - a) If carrier wishes to cancel after the confirmation has been signed, carrier will be held responsible for a **\$100.00 FEE**.
5. **DETENTION POLICY:**
  - a) Barlow will **NOT** be held responsible for the cancellation of loads, or delay of pick up or delivery.
  - b) Therefore, Barlow will **NOT** be held responsible to pay **any layover fees, detention fees or truck order not used**.
  - c) **This applies to all carriers hauling any EXEMPT commodity. NO EXCEPTIONS** will be made.
6. **MISCELLANEOUS CHARGES:**
  - a) All charges must be **pre-approved in writing** by Barlow at least **2 hours** before the time at which charges will start.
7. **FUEL ADVANCES:**
  - a) All advances will be deducted from the invoice total and can only be issued from **9AM-5PM CST, WEEKDAYS**.
